For Windows, Mac and Linux users Photoshop Elements is an alternative to Adobe Photoshop CC. It doesn't include many of the new features in Photoshop CC such as the AI-powered features but the interface, simplicity and the fact that it is free makes it a much welcomed alternative. So, let's quickly see why Photoshop CC is not that suitable for professional work. Only Paid Photoshop CC Subscription can get the AI-powered functionality like the Inner Workflow Panel and

Retopo. Even if you pay for the premium version you can't edit vector images or use some of the newer features like Adobe Lens v2. Some of the newer features in CC like AI are not available in Elements. The Elements interface can be challenging to users who do not use the program for a long time. If you use another graphic editor like Paint Shop Pro or GIMP, you may need to upgrade to the full version of Photoshop. Adobe Photoshop Elements Subscription May Become Free for Students Adobe CS4 Photoshop Elements introduced a new subscription model that has so far been

pretty controversial. The new payment plan allows users to choose to pay for a subscription each month or to pay once for the whole year. Considering its popularity among college students, it is only logical that some students may want to discontinue paying for the full version and may choose to stick to only paying the low subscription fee each month. The licensing is also much simpler - and cheaper - than that of full version. While Adobe is accepting students' feedback, those who are already running on the old license (non-subscription) might be facing some difficulty when Adobe

Q: Completely custom home build I need to build a house. I am in North Carolina. Most of the "finished" floor plans and kits are not feasible for our area and we have very little to use. I have some ideas of what I want. I need a faster process than building our house. I need something that is more do-it-yourself and without the high markup / profit margin. Is there such a house that I can buy and repair/modify it myself? A: I agree with Marc. If you look in Home and Garden magazines, they will have many pictures of homes

for sale that are being built from plans which were purchased elsewhere. They will also tell you the name and home improvement consultants or remodelers that will build these homes. I know of a local contractor that will build you a home for the cost of your current home, with the exception of the improvements. One of the things that I like about the design of these homes is that they often provide instructions on how they came up with the plans. This is good because they often show which ones were purchased from a retailer, and which ones were designed by the builder. For example,

our contractor just built a town home for us. My wife and I planed the plans, and we had a bricklayer make most of the changes to the plans (instead of what the architect would have done), when we met the contractor, he even gave us ideas on how to improve the bricks, which he did not have to do in our case, because we did our own. The only changes he made, which were not in our initial plans, were due to the actual size of the lot. It is possible that the plans he purchased were more detailed than ours, and this was an adjustment needed to accommodate the lot. As a result, he was allowed to

use plans from a different retailer. What we could do to set up your plans, if necessary, is use the plans as a reference to fit the parameters we set in the beginning, modify them as necessary, and then change the plans as necessary to meet your needs. Good luck and have fun. A: I disagree with Marc. You can make your own plans, buy plans on-line, or purchase a kit. But you'll need a bricklayer/architect/framer. the insurer cannot be held liable for any judgment against the insured because of the settlement. Western Casualty & Surety Co. v. Weitzel, 69 F.2d 826, 829 (8th Cir.1934). "[T]he word 'settlement' is uniformly understood in its ordinary legal meaning to denote a compromise in a dispute rather than the act of a mere indemnifier or other intermediate party. It usually means the substitution of a smaller for a larger sum of money, or of that portion of such a sum which is agreed to be substituted, in complete satisfaction of the demand in dispute between the parties, or of those

entitled thereto."... Where a liability insurer has undertaken the defense of the original tort-feasor, the initial settlement by the latter of the claim of the injured person against him is an important factor in determining whether or not the insurer may thereafter question his own insured as to the manner in which his own conduct contributed to the settlement;... the insurer must be held to have impliedly insured the liability of its insured who, in the exercise of his exclusive option, settled the claim as he saw fit by rejecting the liability of his principal. Davenport, supra, at

1177-1178 (emphasis added). See also, e.g., National Casualty Co. v. Henderson, 173 F.2d 545, 547 (5th Cir.1949), where the court declared: The language of the policy refers to "settlements" made by the assured. "Settlement" means a compromise *1131 between the parties thereto and does not require the knowledge or consent of any third person, [and] [a]lthough the policy in terms waives notice of claims and actions, such waiver does not affect the right to insure against judgments resulting from settlements. See also, e.g., Country Mut. Ins. Co. v. Employers

Ins. of Wausau, 626 F.2d 647, 648 (9th Cir.1980), where the court similarly held that the insurer had no defense to its duty to defend its insured where the defense was based on a settlement entered into by the plaintiff without the insurer's knowledge: [T]he policy insured only against tort liability of the assured for injuries which occurred during the policy period. It did not encompass possible liability for the assured's alleged negligence in failing to discover the possible claim
